## Section 2. Hazards Identification

<b>Physical state</b>	: Solid. (Flakes.)
<b>Odor</b>	: Acrid.

<b>Emergency overview</b>	: DANGER!  CAUSES EYE AND SKIN BURNS. FLAMMABLE SOLID. HARMFUL IF INHALED OR SWALLOWED. CAUSES SEVERE RESPIRATORY TRACT IRRITATION. LACHRYMATOR.  Do not ingest. Do not get in eyes or on skin or clothing. Avoid breathing dust. Keep away from heat, sparks and flame. Keep container closed. Use only with adequate ventilation. Wash thoroughly after handling.
<b>Routes of entry</b>	: Inhalation. Ingestion.
<b>Potential acute health effects</b>	
<b>Eyes</b>	: Corrosive to eyes.
<b>Skin</b>	: Corrosive to the skin.
<b>Inhalation</b>	: Toxic by inhalation. Severely irritating to the respiratory system.
<b>Ingestion</b>	: Toxic if swallowed. May cause burns to mouth, throat and stomach.
<b>Carcinogenic effects</b>	: No known significant effects or critical hazards.
<b>Mutagenic effects</b>	: No known significant effects or critical hazards.
<b>Teratogenicity / Reproductive toxicity</b>	: No known significant effects or critical hazards.
<b>Medical conditions aggravated by over-exposure</b>	: Repeated skin exposure can produce local skin destruction or dermatitis. Repeated or prolonged exposure to the substance can produce lung damage. Repeated exposure of the eyes to a low level of dust can produce eye irritation.

### Section 4. First Aid Measures

<b>Eye contact</b>	: Get medical attention immediately. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Chemical burns must be treated promptly by a physician.
<b>Skin contact</b>	: Get medical attention immediately. Flush contaminated skin with plenty of water. Continue to rinse for at least 10 minutes. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing or wear gloves. Chemical burns must be treated promptly by a physician. Wash clothing before reuse. Clean shoes thoroughly before reuse.
<b>Inhalation</b>	: Get medical attention immediately. Move exposed person to fresh air. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.
<b>Ingestion</b>	: Get medical attention immediately. Wash out mouth with water. Remove dentures if any. Move exposed person to fresh air. Keep person warm and at rest. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Chemical burns must be treated promptly by a physician. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.
<b>Protection of first-aiders</b>	: No action shall be taken involving any personal risk or without suitable training. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Wash contaminated clothing thoroughly with water before removing or wear gloves.

### Section 5. Fire Fighting Measures

<b>Flammability of the product</b>	: Flammable solid. Runoff to sewer may create fire or explosion hazard.
<b>Products of combustion</b>	: These products are carbon oxides (CO, CO <sub>2</sub> ), nitrogen oxides (NO, NO <sub>2</sub> etc.), halogenated compounds, hydrogen chloride.
<b>Extinguishing media</b>	
<b>Suitable</b>	: Use dry chemical powder.
<b>Not suitable</b>	: Do not use water jet.
<b>Special exposure hazards</b>	: Not available.
<b>Special protective equipment for fire-fighters</b>	: Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.
<b>Special remarks on fire hazards</b>	: Flammable solid

### Section 6. Accidental Release Measures

<b>Personal precautions</b>	: Immediately contact emergency personnel. Eliminate all ignition sources. Keep unnecessary personnel away. Use suitable protective equipment. Do not touch or walk through spilled material.
<b>Environmental precautions</b>	: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers.

- Methods for cleaning up** : If emergency personnel are unavailable, carefully scoop up spilled materials and use a non-sparking or explosion-proof means to transfer material to an appropriate container for disposal by incineration. Avoid creating dusty conditions and prevent wind dispersal.

## Section 7. Handling and Storage

- Handling** : Do not ingest. Do not get in eyes or on skin or clothing. Keep container closed. Use only with adequate ventilation. Avoid breathing dust. Keep away from heat, sparks and flame. To avoid fire, eliminate ignition sources. Wash thoroughly after handling.
- Storage** : Keep container in a cool, well-ventilated area. Keep container tightly closed and sealed until ready for use. Avoid all possible sources of ignition (spark or flame).

## Section 8. Exposure Controls/Personal Protection

Consult local authorities for acceptable exposure limits.

- Engineering measures** : Use only with adequate ventilation. If user operations generate dust, fumes, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. The engineering controls also need to keep gas, vapor or dust concentrations below any lower explosive limits. Use explosion-proof ventilation equipment.
- Personal protection**
- Eyes** : Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or dusts.
