Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: green solid.

Warning! Carcinogen. May cause allergic skin reaction. Methemoglobin former - can cause cyanosis. May cause eye and skin irritation. May cause respiratory tract irritation. May cause cancer based on animal studies.

Target Organs: Blood, thyroid.

Potential Health Effects

Eye: May cause eye irritation.

Skin: May cause skin irritation. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material.

Ingestion: May cause effects similar to those for inhalation exposure.

Inhalation: May cause respiratory tract irritation. May cause methemoglobinemia, cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood), convulsions, tachycardia, dyspnea (labored breathing), and death. May cause anemia.

Chronic: Possible cancer hazard based on tests with laboratory animals. Chronic exposure can affect thyroid function. May cause pituitary gland abnormalities.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid immediately.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

Ingestion: If victim is conscious and alert, give 2-4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Get medical aid immediately.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Notes to Physician: Absorption of this product into the body may cause cyanosis (bluish discoloration of skin due to deficient oxygenation of the blood). Moderate degrees of cyanosis need to be treated only by supportive measures: bed rest and oxygen inhalation. For methemoglobinemia, administer oxygen alone or with Methylene Blue depending on the methemoglobin concentration in the blood. Cleansing of the entire contaminated area of the body is of utmost importance.

Section 5 - Fire Fighting Measures
