### Section 3 - Hazards Identification

#### EMERGENCY OVERVIEW

Appearance: viscous liquid.

**Caution!** May cause eye, skin, and respiratory tract irritation.

**Target Organs:** Respiratory system, eyes, skin.

#### Potential Health Effects

**Eye:** May cause eye irritation.

**Skin:** Prolonged or repeated contact may dry/defat the skin and cause irritation. Not expected to cause an allergic skin reaction. A single prolonged skin exposure is not likely to result in the material being absorbed in harmful amounts. Undiluted cedarwood oil Virginia applied to the backs of hairless mice was not irritating. Applied full strength to intact or abraded rabbit skin for 24 hours under occlusion, it was moderately irritating.

**Ingestion:** No hazard expected in normal industrial use. Ingestion of large amounts may cause gastrointestinal irritation.

**Inhalation:** May cause respiratory tract irritation.

**Chronic:** No information found.

## Section 4 - First Aid Measures

**Eyes:** In case of contact, immediately flush eyes with plenty of water for a t least 15 minutes. Get medical aid.

**Skin:** In case of contact, flush skin with plenty of water. Remove contaminated clothing and shoes. Get medical aid if irritation develops and persists. Wash clothing before reuse.

**Ingestion:** If swallowed, do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Get medical aid.
